

Message from Association President Morton Harris '52



It has been an exciting and challenging four years since the formal establishment of the Columbus High Alumni Association in March of 2009 when our Association was incorporated. During the prior

year, several alumni had

gotten together to help sponsor the celebration of the 100th anniversary of the Columbus - Jordan football game which included a special ceremony during the game at Memorial Stadium and a weekend of alumni events.

Following the celebration, the group stayed together and organized the CHS Alumni Association and, among other things, helped with the renovation of an alumni memorabilia room at CHS and held an alumni event for all past graduates. The leaders during this formative year were **Cecil Calhoun '52, Betty Brinson Bush '53, Milton Jones '54, Margie Alexander Drury '59, Ken Crumpler '61, Gloria Jones Dodds '62, Pat Hill Lane '64, Vickie Logan Rounsaville '66** and **Judy Whitt** who was then Assistant Principal (soon to become Principal) at CHS. Many others were also involved.

During this time, Cecil recruited me to the Association with a request to form a charitable non-profit corporation for the purpose of providing financial support to enable all deserving students at CHS to fully participate in the school's many cultural, leadership and academic opportunities and to enhance the already outstanding academic achievements at Columbus High. After incorporation, the Association applied to the Internal Revenue Service for a ruling that our Association be designated a public charity under Section 501(c)(3) of the Internal Revenue Code so that all contributions to the Association would be tax deductible and all earnings on our investments would be tax-free. A favorable ruling was received on June 6, 2009.

In March of 2009, the first CHS alumni newsletter (later to become *The Orange & Blue*) was published which featured the highlights of the Columbus - Jordan festivities and also contained information about the Association.

In 2010, we began helping students with their participation in various academic, cultural and leadership activities by providing funds to cover certain student expenses. We also initiated the first "Dream Trip" and financed a deserving student's visit to mainland China.

In December of 2010, we created a permanent endowment to be known as the CHS Endowment for Excellence and entered into an agreement with the Community Foundation of the Chattahoochee Valley for the Community Foundation to serve as custodian of our Endowment funds and manage its investments. The income from the Endowment Fund is transferred by the Community Foundation to our Association. With these funds and additional monies from member dues and contributions, our Trustees (after determining the areas of student priority needs with input from the CHS principal) transfer funds to be used in support of students in each identified area. Some of these areas of student support have included paying the costs for taking Advanced Placement tests, participating in field trips and the costs associated with the school's personal development and etiquette program. We have also continued our support of one or more students selected by the faculty to take part

in the Dream trip visits to foreign countries along with other students.

Throughout 2011 and 2012, we solicited the initial funds for our Endowment and by March of 2013, through generous contributions from numerous alumni and friends of education, the Endowment received over \$360,000. A plaque memorializing our Founding Donors was formally dedicated in the courtyard at CHS on March 26, 2013. Almost immediately after the Dedication Ceremony, an already generous alumnus called me to offer a matching pledge of \$70,000; and during the next few months, we were successful in raising an additional \$70,000 in a matching fund campaign. Today, the CHS Endowment for Excellence has over \$500,000 in investible funds and several remaining pledges, all of which are current.

During these past years, we continued our support of CHS and expanded the membership of our Association including the creation and funding of the Spirit Award in 2012 - funded and implemented by Judy Whitt and her husband, Randy, to recognize outstanding teachers at CHS. Since the beginning, our Association has sponsored alumni social events each year, where alumni and friends have met to renew old friendships and make new ones. In 2013, we began developing a mentoring program for students involving community leaders who meet with students at the school and describe their particular business or profession and answer the students' questions about their future careers. Thanks to Cecil Calhoun for developing the program and to Ken Broda '87 and Carl Rhodes '75 who are bringing it to fruition. Also during this past year, we began to improve our website and connected

Lifetime Members Successfully Launch the Alumni Association

We wish to thank the 311 Lifetime Members for their financial support in getting the Alumni Association off to a tremendous start. The Lifetime Member designation was frozen as of March 1, 2014. These contributors are the foundation of the Association and will be forever enshrined in the Alumni Room at CHS. This group of alumni and friends allowed the association to be up and running quickly and with their efforts, along with many other financial supporters, Board members and friends, the Association has raised an Endowment Fund valued at over \$450,000 not including additional pledges of almost \$100,000.

Our goal is to increase the Endowment Fund to \$1 million by the end of 2015. To sustain the Fund's future growth and the continued operation of the CHS Alumni Association, the Board of Trustees decided to revise its annual dues into an 'annual giving campaign.' This allows alumni and friends to donate annually, provide memorials and honors to others and make contributions in recognition of the importance of continuing to support CHS. You will receive a letter from the Association in the coming weeks outlining the details of the program.

To date, the Association has contributed \$30,999 directly to CHS. These funds provide students in need with numerous opportunities that, otherwise, would not have been possible. These opportunities include:

- Social fees and field trip fees
- Supplement Freshmen Lunch and Learn where Freshmen are introduced to the CHS Manners/Etiquette program
- Partial Dream Trip Scholarships
- Advanced Placement for students who otherwise could not afford to take the exams
- Supplement costs for Academic competitions including Debate Team, Math Team, Academic Decathlon, Literary Meet, Model UN, Odyssey of the Mind, Science Olympiad and FLAG

In closing, we, the Board of Trustees and CHS, thank you for your past support and sincerely hope you will offer the same generous support in the future.

Thanks again for all you have done and continue to do for CHS!

WHAT IS CHS ALUMNI ASSOCIATION, INC.?

Columbus High School Alumni Association, Inc. was formed in 2009 as a non-profit Georgia corporation with 501(c)(3) charitable status affording tax exempt benefit for **all** contributions to its annual giving campaign and Endowment Fund.

WHO CAN CONTRIBUTE?

Anyone who attended or graduated from Columbus High School and anyone (including parents of CHS students and children of CHS alumni) who wants to assist and promote CHS and its students.

WHY SHOULD I CONTRIBUTE?

To unite with others who support a nationally recognized, high quality liberal arts high school program.

To be a part of a large group of people who appreciate Columbus High and the positive influence on its students and the community for 122 years.

WHAT PROJECTS ARE CURRENTLY UNDERWAY?

The CHS Endowment for Excellence was established in 2010. The Community Foundation of the Chattahoochee Valley manages the Endowment Funds. The income from the invested funds is being distributed to Columbus High School to help provide educational opportunities for students, both inside and outside the classroom for academic-related requirements such as field trips, school wide annual formal dinner, funding of Advanced Placement course exams for which students can receive college credit and other assistance to deserving students.

Alumni Association Dream Trip program that sponsors deserving students on summer faculty led study trips abroad. One student was sponsored on a trip to China in 2010. During the summer of 2011, one student was awarded a trip to Greece and another student a trip to Spain and Morocco.

with OmegaFi to better enable our members to participate in financially supporting CHS.

In 2014, we are considering adding to our areas of support by helping fund student visits to several colleges in the Southeast for those who would otherwise not be able to do so. Thanks again to Cecil Calhoun for suggesting this project.

CHS continues to maintain its top class reputation for academic excellence, having been named the number one public high school in the State of Georgia during the 2012-2013 school year. During the past decade, Columbus High School has consistently been ranked by U.S. News & World Report as one of the top public schools in the United States, and has had more of its students receive scholarships to top universities throughout the country than almost any public school in the state of Georgia. During the past few years, more students from Columbus High School have attended MIT than from any other public school in Georgia.

A special activity at CHS for which all alumni can be proud is its Robotics Program, which has for several years worked with the robotics section at Ft. Benning and has competed successfully in international robotics competition. In 2013, the CHS team was recognized as one of the top achievers in a worldwide robotic competition and is expected to do even better this year. There is also another group of dedicated students at CHS who for several years have been associated with NASA in building and experimenting with space rockets under the guidance of an inspiring physics teacher, Luther Richardson.

I could not finish my last message as President of the Association without recognizing and thanking my assistant, Mary Ray, for all of her valuable support during these past four years and the many things she has done to help our Association and its leadership.

Finally, I want to express my appreciation for the privilege and honor of serving with so many enthusiastic and committed people in our efforts to make a positive impact on the lives of dedicated and bright young students who attend Columbus High, many of whom will become the future leaders in our community. My sincere thanks go to all of those who have given so generously of their time and efforts and financial support on behalf of our Association and to those special people for making my past four years as President so enjoyable and meaningful.

Our very own Frank Thomas '86 has been selected to the Baseball Hall of Fame. From his early days in Peach Little League he was a stand out. His coach Jack Key knew he had potential for greatness, but

nothing like this. Over 18,000 people have played professional baseball, but less than one percent have been selected into the Hall of Fame.

Frank Baird, his Auburn Baseball Coach said, "He was the best baseball player Auburn ever had and I think Frank is the only player to reach the Hall of Fame from the Southeastern Conference." Bobby Howard, his Columbus High School Coach said, "All the glory goes to Frank and well it should."

Frank Thomas wanted to be the best hitter in Major League Baseball and his record exemplifies it. He played 56 percent of his games as a designated hitter and is the first Hall of Famer to have played a majority of games at the designated hitter position.

Frank Thomas was inducted into the Georgia Hall of Fame on February 22, 2014. He has also been inducted into the state sports halls in Illinois and Alabama. He is to be inducted into National Baseball Hall of Fame in Cooperstown, NY on July 27, 2014.

We've attained many heights in many areas over the years at Columbus High School, but none greater than our own Frank Thomas.
